

Echo Mesa Men's Golf Club

October 13, 2015

President Tim Williams called the meeting to order at 2:00 PM. Other Board members present: Gene D'Arcangelo, Dick Anderson, Gene Lindmeyer, Ed Siddy, Ken Skinner, and Mick Waas. Guest included: Frank DeBold, Larry Anderson, and Nancy Hewes, Club Monitor.

Mick moved, Ken seconded, that the Board minutes of Sept. 8, 2015 be approved as printed and posted. Motion passed. Treasurer Ed reported that there was no income or expenses the month of Sept. so the Bank account balance remains at \$1750.88 on October 1, 2015.

President Williams introduced Frank DeBold and Larry Anderson as candidates for the 2016 Board. Gene Lindmeyer stated that after 2 years on the Board he would like to retire. Dick Anderson had already said at the last meeting that after 3 years on the Board he would retire.

There was a discussion on charging club members an additional \$5.00 for delinquent dues after Jan. 1. It was decided not to add this charge but that delinquent members would be dropped from the roster and could not participate in the sweeps, etc. until dues are paid. Extra effort will be made to collect dues. Nancy stated that she needs the names of paid up members by 12/16 if their name is to be in the Club Handbook.

President Williams reported that he had attended the Chartered Club RR&P meeting, 10/1/15. Pres. Tim requested volunteers to man a table at the Newcomer's Coffee Open House on 10/29/15 with Frank DeBold and Larry Anderson responding.

It was decided to have the Best Ball tournament on 10/21 instead of 10/14 as scheduled because of sharing the course with Stardust. See the back of the scorecard for tournament rules.

On Nov. 11, 2015 a Fun Day with a scramble format is scheduled with free pizza and drinks. There will be a 7:30 AM shotgun start. Gene Lindmeyer has the pizza caterer scheduled and several Board members agreed to help with setting up tables before golf.

The General Membership Luncheon meeting will be Nov. 17, 2015 starting at 11:00 AM at Palm Ridge Summit Hall B. Gene Lindmeyer reported that Memo's Bistro will cater the lunch. There will be a speaker and a drawing for sleeves of golf balls. Gene D'Arcangelo will get trophies for this year's four Hole-n- One golfers. Because of the high cost of caterer's Dick A. moved, Gene L. seconded that: Club members will pay \$5.00 to attend the luncheon. Motion passed. Luncheon ticket sales to members will start on October 28, 2015. (Wednesday)

Pres. Tim reminded everyone that it is time to start plans for the 2016 Club Handbook. The Board members selected present advertisers that they would contact plus other possible business and professional firms for advertisements. Nancy said if she had the advertisements by the middle of Dec. she could have the Handbook out the first week of Jan.
